Annual General Meeting

The AGM was held on 20th January in the Amenities Centre. A total of 15 members attended the AGM plus three local councillors and the Highland Council Ward Manager, Di Agnew. The councillors that attended were Angela Maclean, Margaret Paterson and Graham Mackenzie.

After I gave a summary of the main activities that had occurred during the previous year the new board of directors was elected. The following directors were elected at the meeting.

Jane had been the treasurer for the previous 12 months, but not a director. It was thought that the board should have a financial director specifically responsible for the finances of the company. Jane agreed to become the financial director.

In order to wait until the lottery application outcome was known the previous board had decided to hold off having the AGM until January, rather than in October. Since the accounts had to be submitted to Companies House by March 2016 it had been decided by the previous board to submit these to the Accountants Mackenzie Kerr to produce a formal financial statement before the March deadline. This would avoid the risk of a financial penalty for the Maryburgh Amenities Company. The meeting concluded with discussion to arrange a meeting with the board, councillors and Di Agnew. Di Agnew stated she had postponed the report to the Asset Board until the beginning of March, therefore she asked if the meeting with the board could be convened prior to this. The new board arranged for the first board meeting to be held on the following week, on Tuesday 26 January. It was decided to arrange the meeting with the councillors after this board meeting. This first board meeting was however delayed until the first week in February.

The first meeting of the new board of directors was held on 3rd February 2016. The Maryburgh Community Council have two director positions on the board. These positions were filled by Jenny MacLennan and Andrew Steel.

Climate Challenge Fund

The Keep Scotland Beautiful -Climate Challenge Fund (CCF) was approached for help with improving the Amenities Centre heating. On the 9 February Jenny Maclennan received a reply from Keep Scotland Beautiful with the following comments:

Unfortunately, we are not able to fund efficient renovation project without a wider behaviour change project and we are unable to fund new heating system or micro renewables.

CCF has three overarching criteria that all projects must meet to be considered eligible for funding these are Community, Carbon and Legacy.
