# Organisation

The Maryburgh Amenities Company Ltd is still not registered with the Office of the Scottish Charity Regulator (OSCR). Until the company is registered as a charity with OSCR we may have to pay tax to HMRC on any profits made by the company. When our statement of accounts is sent to Companies House at the end of June, any money in our account may be identified as profits. This may be money raised by hiring the Community Centre or money raised by volunteers by fundraising.

The reason we are not registered with OSCR is that because the company is transferring our charitable status from the Maryburgh Amenities Association. To do this all the assets belonging to the Association need to be

transferred to the Maryburgh Amenities Company first. The only asset still outstanding is the lease from the Highland Council for the land the Community Centre is built on and the football pitch. This was discussed by the Highland Council on the 13 March 2013. The following is an extract from the draft notes of that meeting:

The community is currently setting up a charitable company limited by guarantee whose remit will be to improve the quality of life of people living and working in the area. It is hoped that it will have the capacity to help local individuals and small businesses and complement the range of other facilities and services found in the area.

Taking ownership of the whole site, including those areas already leased to Maryburgh Amenities Association by the Highland Council, will give the community control of the full range of opportunities to develop income streams to fund the

maintenance, repair and running of the community facilities.

The Group, along with Maryburgh Amenities Association, are working towards forming a Company Limited by Guarantee. They have received permission from OSCR and have sought legal advice on transfer, lease and ownership of other assets (the MAA currently lease the adjoining football pitch and land on which the Community Hall is sited). It is anticipated that the Company (Maryburgh Amenities Company Ltd) will be in place and current assets transferred prior to 31 August 2013.

The company was registered with Companies House in June 2013 but the lease transfer has still not been completed despite assurances this matter is now being fast-tracked through the legal department.

## **Building Inspection**

In response to a letter of complaint regarding the Community Centre facilities the Maryburgh Board of Directors carried out a visual inspection of the building and surrounding area to identify existing problems and list improvements to be carried out. The following list indicates the problems that need to be addressed:

- · Pot-holes and broken paving
- External lighting
- Drainage gutters & downpipes
- Blocked toilets
- No guards on fluorescent light
- Store room extension roof
- Broken window in changing room
- Damaged floor panel on stage
- Inadequate heaters
- Walls need a fresh coat of paint
- Flooring in entrance hall
- Damaged & missing Ceiling tiles
- Hole in the wall

The money raised each year through the Gala day and hall hire charges is just sufficient to cover ongoing costs such as heating etc. There are not sufficient funds to carry out many of the repairs needed. Some of the problems identified can be rectified at very little expense. All that is needed are volunteers to give up some time to help. Other problems will need fundraising if they are to be achieved. Again we need volunteers to help organise fundraising events to raise the money needed.
